- 2. Read, comprehend, sign, attach and abide by the MFFI Makers' Market Charter.
- 3. Hold \$10M public liability insurance. A small number of stalls are available for those without insurance which can be covered by MFFI insurance for \$10 per attendance.
- 4. Meet all relevant government regulatory food, safety and labelling obligations.
