1. Read, comprehend, sign, attach and abide by the MFFI Farmers' Market Charter.
2. Complete a MFFI Farmers' Market Application Form initially. Then following the introductory period, be approved by the MFFI Committee for ongoing attendance.
3. Hold \$10M public liability insurance. A small number of stalls are available for those without insurance which can be covered by MFFI insurance for \$10 per attendance.
4. Meet all relevant government regulatory **food, safety and labelling** obligations.
